Notes:

- 1. Pursuant to Regulation 41 of the Uncertificated Securities Regulations 2001 (as amended), only those members registered in the register of members of the Company as at Close of Business on 16 June 2023 (or if the AGM is adjourned, on the day which is two business days before the time fixed for the adjourned AGM) shall be entitled to attend and vote at the AGM in respect of the number of shares registered in their name at that time. Any changes to the register of members after such time shall be disregarded in determining the rights of any person to attend or vote at the AGM.
- 2. Information regarding the annual general meeting, including information required by section 311A of the Act, is available from www.corero.com/about/investor-relations/shareholder-information.
- 3. Shareholders, or their proxies, intending to attend the AGM in person are requested, if possible, to arrive at the AGM venue at least 10 minutes prior to the commencement of the AGM so that their shareholding may be checked against the Company's Register of Members and attendances recorded.
